
Attached to this staff report is a project matrix developed as a project management communication tool to provide updates on the current delivery status of projects on the state highway system. For these major highway projects, SJCOG is an implementing agency, financial sponsor, or both and shares in the responsibility in helping to insure the successful delivery of the projects identified. Please see project notes section on the spread sheet for related information.

State Route 99/120 Connector Project Update

The San Joaquin Council of Governments is the sponsor and implementing agency for the current phase of work which is Project Approval Environmental Document (PA&ED). Caltrans prepared the Project Study Report and is the lead agency for this project. This project is being developed in partnership by the two agencies and also includes the City of Manteca. Work continues to progress on this project and significant issues have been identified and addressed to move the project ahead in environmental analysis and preliminary design. The Project Development Team has further refined the traffic and operations to help better determine the two build alternatives to address improving the operations at the state highway to highway connector.

SJCOG staff presented the refined Project Study Report alternatives to the Manteca City Council meeting in April. SJCOG staff received feedback, and as a result, has made improvements to the project alternatives. The next steps are to present the updated project alternatives at a public map showing to be held in the City of Manteca at the end of June or beginning of July. At the public map showing, the Project Development Team will continue to gather information from the public about the proposed alternatives. The final alternatives will be displayed at a public hearing in the fall to finalize the environmental document. The final environmental document is anticipated to be completed by January 2018. Construction is anticipated to begin by 2019/2020 depending on which alternative or phase of construction is selected after the final environmental document is approved.

SJCOG requested funding in April for the portion of the project that is the Austin Road overcrossing at the annual "One Voice ®" trip in Washington D.C.
