SUBJECT: Measure K Renewal Cooperative Agreements

for Bicycle, Pedestrian, and Safe Routes to School and Smart Growth Incentive Program

Projects

RECOMMENDED ACTION: Authorize the Executive Director to Execute

Measure K Renewal Cooperative Agreements for the not-to-exceed amounts as shown in Table 1, with a total not to exceed \$19,630,000

SUMMARY:

On February 22, 2018, SJCOG Board awarded a total of \$19,630,000 of competitive funding from the Measure K Bicycle, Pedestrian, and Safe Routes to School Program and the Measure K Smart Growth Incentive Program to 21 projects and plans. In order to access Measure K funding, the project sponsors must enter into Measure K cooperative agreements with SJCOG and the funding and project descriptions must be consistent with the Measure K Strategic Plan. The recommended cooperative agreement amounts are consistent with the program of projects as adopted by the SJCOG Board and the 2017 Measure K Strategic Plan.

RECOMMENDATION:

SJCOG staff recommend the Board authorize the Executive Director to execute the 21 cooperative agreements for the not-to-exceed amounts as shown in Table 1, not to exceed a total of \$19,630,000.

FISCAL IMPACT:

Approval of staff's recommendations will result in the allocation of \$11,855,460 of Measure K funding from the Bicycle, Pedestrian, and Safe Routes to School subcategory and \$7,774,540 of from the Smart Growth Incentive Program for a total amount not-to-exceed \$19,630,000.
